Host Close	1 - 5 Free Form		HOSTCLOSE	Set to Y if your account is set up on FIS' side to do automatic batch closing. Leave empty or set to N otherwise.
EMD Settle	1 - 5 Free Form		BIGBATCHSETTLE	Set to Y if your account will setting using big batch file. Such as using FIS' EMD file. Only credit sale and return transactions are big batch settled.
